

Data Privacy consent declaration according to European General Data Protection Regulation (GDPR)

I am in consent with the fact that PATH MEDICAL GmbH collected, processed and used my personal data as well as passed them on respectively transmitted them to PATH MEDICAL distributors to be processed and used there as well for the following purposes: (as a customer, we understand end users, distributors, suppliers, service provider and consultants, in the following referred to as "customer"):

- customer information, administration of customer data
- service requests, order inquiries, invoices
- release notes, advertising, correspondence

My data will be stored and processed for the duration of the business relationship with PATH MEDICAL and will be completely deleted upon termination of such business relationship (including persisting contractual obligations) or on my written revocation respectively.

The transmission to PATH MEDICAL distributors occurs only in the context of a unique appropriation according to GDPR (e.g. on specific occasion like placement of an order). Hence, my personal data is transmitted to third parties solely, if:

- I have given my explicit consent according to Art. 6 para. 1 S.1, GDPR,
- the transmission according to Art. 6 para. 1, GDPR is necessary for enforcement, exercise or defense of legal claims and no reason exists to assume that I might have predominant protectable interest in the nonproliferation of my data,
- legal obligations for transmission according to Art. 6 para. 1, GDPR exist, as well as
- it is legally permissible and necessary according to Art. 6 para. 1, GDPR for the execution of contractual relationships with me.

Should the processing of my data take place outside of Europe, this transmission takes place under adherence to all effective data privacy laws and specifically to Art. 44 GDPR. I was advised that my personal data collected in the context of the preceding purposes are collected, processed used and transmitted under adherence to the European General Data Protection Regulation.
